As all of you knew that AFP surveillance is an integral part and one of the four pillars of PEI programme. In order to timely detect WPV/ cVDPV2 virus circulation and timely respond to any outbreak we have a well established surveillance system at district, provincial and national level. Active surveillance through visits to designated facilities by dedicated district level officers and passive surveillance through weekly zero reports duly signed by the facility incharge and supervised and collected by WHO staff is established for timely reporting of AFP cases.

RHC Pashat is a weekly active site visited regularly by DSO. The said facility was visited on 1st Sep. 2020 by DSO and on 11th Sep. 2020 PEO Bajour visited the facility to participate in UPEC meeting and also did the active site visit. While checking the facility OPD register the PEO noticed an AFP case labelled as Injection Neuritis on 3rd Sep 2020 but neither notified by the doctor on duty nor recorded in the weekly zero report/ VPD report and the case has became inadequate due to the negligence of the doctor on duty as well as negligence of UCPOs/TCSP of the said facility as coordination with the facility staff for AFP surveillance is a part of their TORs. The concerned doctor on duty and health facility incharge is intimated through DHO office to explain their position for negligence. You are hereby directed to explain your position for negligence in TORs and lack of professionalism and lack of coordination for timely reporting of AFP case due to which an adequate case has became inadequate.
