Dear Imran

Following are the observations shared by the Dr. Illaudin from National EOC in the UC of Mr. Karim Bux Malik UCPO Saifal and take necessary action as per SOPs.

CR July campaign was started with incomplete microplans, UC compilation sheet was not filled, team indicators (Local, Female and Gov't accountable) were not marked on the team composition formats, area compilation sheet were incorrectly filled. Microplan self-assessment by AICs was not done. Microplan review and validation was not done by UC level monitors.

UCPO is working in the UC, with no evidence of inputs and support in microplan preparation, data analysis and capacity building of AICs and UPEC chairman.

Multiple mistakes in tally sheet filling and recording of missed children were noted during desk review of two days tally sheets. Micro plans incomplete, formats incorrectly filled, desk review and field validation not done. No revisit of vaccination teams/low same day missed children coverage Tally sheet/Data analysis on daily basis during ERM at UC level and teams with low missed children coverage to be pushed for revisit
