According to attached TORs "Point # 10" UC Polio Officer is responsible to "train and supervise UC level operations and communications officers and Area Supervisor".

According to attached transformation guidelines Page 3 & Page 4;

- UC Polio Officer is Functional Reporting Officer of UCDO and UCO (Transformation Reporting Line Page # 3)
- UC Polio Officer is responsible to ensure daily attendance and presence of subordinate staff at duty location and update admin supervisor /3rd party which ever applicable (Page # 4 Point 2)

We understand that these guidelines are under revision.. however, PTPP staff has already allocated in Trier-1 districts as per the attached letter issued by National EOC dated 13th March 2020, and attached TORs have been shared with all UC Polio Officers working in Teir-1 districts.

These guidelines have been implemented in field since July 2020 i.e. we are receiving PTPP staff attendance from Tehsil Delivery & Operation Officer (Previously DHCSOs), leaves are approving by TDOO, UC Polio Officers are approving UCDO and UCO and other subordinates leaves, UC Polio Officers are following attached TORs in day to day task. Additionally, as per contract issued by CTC to UCDO and UCO, UC Polio Officer is their first level supervisor.

The recommendation has been made on the basis of transformation guidelines and reporting line. Mr. Nadeem Khan has himself admitted in response that he was aware of this act and being a functional supervisor he has to stop this act and report it to the seniors which he don't. That's' why he is recommedmed for warning.

In continuation to below email following updates are to be shared as per the inquiry conducted:

• A compliant was lodged against UCDO Zooma Meer of UC Khalisa-1 on account of instructing Staff to update the register in back date. In order to probe the matter further we have conducted a detail inquiry below are the key findings :

<u>Key Findings :</u>

• As reported earlier the attendance register of Staff at UC Khalisa -1 was updated till March only and not after that. (Pictorial evidence attached as Annex -1).

- As per CTC visit to BHU and register re-checking , it was found out that the attendance register was updated for the month of August and September 2020 in back date by all UC staff except for AS Ms. Rida and her team.
- The pictorial evidence of all the staff attendance updated in register is attached.
- Upon investigation that why the employee (Ms. Rida) and her team has not marked the attendance in the BHU register, she has mentioned that UCDO has instructed them to update the register on 6th October, 2020 after the initial visit of CTC representative at the BHU. (Her written statement is attached)
- In light of the evidences it is found out that indeed employees have updated the register in back date.

Recommendations:

As suggested earlier following actions are recommended :

- Show cause followed by contract closure for UCDO Ms. Zooma Meer as she has already received final warning on weak monitoring and supervision skills, previously, marking of attendance in back date is an act of " Data fudging " and she has misused her authority by compelling her subordinates to mark the attendance in back date as well as it is setting wrong example of UC supervisor who is instructing staff to perform such an act.
- Show cause followed by warning is suggested against UCPO who is a UC Manager after transformation, he has neither reported this activity nor have play his supervisory role to stop this act from happening.
- The findings will be shared with WHO concerned team for endorsement from respective supervisors.
