Dear Imran,

I would like to bring to your attention the issue of fake signing of RSP cards by UCPO Abdul Rahim of UC 1 Mominabad, Orangi.

UCPO Abdul Rahim, signed the cards in place of the RSPs deployed in Orangi town during the October SNIDs. During investigation and on personal hearing before the District Polio Officer (ADC-1) West and Deputy District Polio Officer (AC-WHO) the UCPO confessed on faking signatures of RSPs for submission of DDM cards on time.

Based on the confession by UCPO Abdul Rahim, it is concluded that UCPO Abdul Rahim is guilty of faking signatures of RSPs. However, his involvement in any sort of financial embezzlement could be established.

It is suggested that a written warning may be issued to UCPO Abdul Rahim to discourage any such practice in future.
