Respected Sir Nadeem Jan

Greetings for the Day.

Hope this email will find you in good health in these challenging times.

Meanwhile, I am shocked that one of AFP Case, belongs to my area of responsibility has been missed by the HCPs in my area of responsibilities. Lately, the same case was finally notified by (**Dr. Rasam** Pediatrician at District Headquarter Hospital Landi Kotal. In-fact, this is the only case that was lately notified in my area of responsibilities in the year 2020.

The said case which I mentioned above namely **Shahzaib S/O Tayab** age 8 years, with diagnosis of *Facial Palsy* has an onset on 7th of October 2020 as per parental recall. On October 8th, 2020, the child visited Dr. Liaqat Ali *(An Active Reporting Site located at UC Sheikhmal Khel)* and was labeled as *Facial Palsy* but not notified to the field staff as well as to the concerned PEO/TPO. This site is also not in my area of responsibility after my transformation from TCSP to UCPO.

The Patient then went to the **Hayat Abad Medical Complex** on 15th of October 2020; - from where the child was still not notified although clearly labeled as *Facial Palsy*.

The child then came back home and upon no recovery, on 24th of October 2020, went for Consultation to Dr. Rasam at DHQ Hospital Landi Kotal. Dr. Rasam immediately notified the child as an AFP and referred him to the EPI section located at Landi Kotal Hospital for further necessary action (Dr. Rasam Medical Receipt attached with this email).

Keeping in view all the above events I was helpless in notifying the said case in time.

As a precautionary measure I still revisited the HCPs, of all my areas and re-emphasized the importance of AFP Surveillance. I had redirected all the UC Staff to be vigilant regarding the AFP Surveillance. Meanwhile, a three day sweep activity was conducted and a result of this activity *57 newborn* and **one AFP (Ajra D/O Mukaram Khan age 21 months)** reported in the sweep activity from the area of Mukhtar Khel. The child was immediately taken to Dr. Hamid Pediatrician at DHQ Hospital, where after thorough diagnosis labeled as non AFP case.
