> I've received today a show cause letter from you on account of

> embezzlement.

> First of all I want to state that I have been working as UCPO since

> 2018 and there is not a single complaint raised against me by any one
> for any misconduct or unprofessional attitude.
>
> As far as current complaint of fake signature of RSPs done by me is
> concerned, I want to clarify that this is nothing to do with financial
> embezzlement or fake data submission as stated in show cause letter.
> The reality is that I was assigned to fill the DDM cards of all 17
> RSPs of Orangi Town and submit to DEOC for Assistant Commissioner's
> signature. As this task is assigned during SNID October campaign and
> the deadline for submission of DDM card is very short and it is very
> difficult to gather all RSPs at one place and also difficult for me to
> go to all 17 RSPs to collect their signature on DDM cards due to
> hectic campaign activities, I with the permission of all RSPs put
> their signatures on their respective cards in order to save time and
> complete the task in given time. RSPs gave this permission because
> they certainly know that putting their signature by me on their cards
> would do not harm to them and their payment. In any case their payment
> will be submitted in their own accounts. I again insist that there is
> no chance of any financial embezzlement in such case as there is
> official list of RSPs in DEOC and WHO provincial office and before
> approving any DDM card by finance department all cards are tallied by
> this list. You can check all DDM cards submitted by me whether these
> are according to that list or not.
>
> Although I did this with good intention and without a trace of

> dishonesty, now I realized that I should not have done this. I whole
> heartedly accept my mistake, apologize and assure you that in future
> this sort of act will not be happened.
