Respected Syed Imran,

I wish and pray that this email finds you well.

As discussed in our telephonic conversation a while ago, I am sharing the grave observations received from respected AC-WHO Sukkur Division against UCPO Mr. Javed Junejo, UC Sagyoon Taluka Sobho Dero of District Khairpur. Here's the summary of key observations and recommendation from my side:

- * The UCPO filled ROUGH PAPERS AS A MATTER OF THE FORMALITY OF SUBMISSION OF CLUSTERS. He did not use official formats of ICM Clusters on field which is contrary to SOPs of monitoring and supportive supervision.
- * Three of the clusters taken by UCPO, were verified. The selection of one areas for clustering was found to be unjustified.
- * One of the clusters taken from Village Muhammad Ramzan Mashori by
 the UCPO had shown 1 REFUSAL FOR WHICH HE WAS FURTHER ENQUIRED. UPON
 FURTHER PROBING, THE STATEMENTS WHICH WERE PRESENTED BY THE UCPO DID NOT
 MATCH WITH THE TALLYSHEET DETAILS. This showed that UCPO either did not
 verify the child or had taken the cluster while the mobile team was
 vaccinating the same houses.
- * The UCPO had NO TEAMS MONITORING CHECKLIST WITH HIMSELF. UCPO HAD NO CHECKLISTS FOR THE TP AND FIXED SITE MONITORING TOO.
- * SMT SUPERVISOR MR. SYED ALI RAZA SHAH WHO ULTIMATELY REQUIRES SUPPORT FROM UCPO IN THE UC WAS ALSO MONITORED, HE ALSO HAD NO CHECKLISTS AT ALL.
 - * THE DEFINITIONS OF RCA AND MA WERE NOT CLEAR TO THE UCPO.

- * The UCPO was also found non-familiar with the EI Categories.
- * Upon the field visit to the Village Suleman Kalhoro, T:03, Day 01,

Following children were found from the SMT Area which came within the category of Operational Failure.

- A) RABIA D/O MUNAWAR KALHORO 3 YEARS OLD.
- B) KHUDA BUX S/O MUNAWAR KALHORO 12 MONTHS OLD.

BOTH WENT TO KANDYARO ON SUNDAY AND RETURNED AFTER THE TEAM VISIT. BOTH WERE FOUND NOT RECORDED WITHIN THE TALLYSHEET.

C) MUHAMMAD HANIF S/O MUHAMMAD AMEEN 2 TO 3 YEARS OLD; WENT TO HINGORJA FOR THE MEDICAL TREATMENT BEFORE THE TEAM VISIT AND ARE NOW RESIDING AT SIDDIQUE KALHORO STILL).

ALL OF THESE ABOVE 3 CHILDREN WERE FOUND NOT WITHIN THE TALLYSHEETS.

Moreover, 2 Unrecorded Zero Dose Children were also found from the same village.

RECOMMENDATION:

* An official explanation letter shall be issued to UCPO Mr. Javed Ali Junejo, UC Sagyoon Taluka Sobho Dero for his sheer negligence on field and not adhering to campaign monitoring SOPs. This will help maintain accountability file of the UCPO at my side for future reference.

I look forward for your usual support in this matter so that further necessary steps are taken. The observations file is also attached for your study and support.

Dear Dr. Suhail Ahmed,

Greetings and Congratulations for the successful completion of the NID Nov Campaign.

Following key observations are shared with you formally during the field visit to UC Sagyoon within the NID-Nov Campaign.

- * The UCPO had filled the ROUGH PAPERS AS A MATTER OF THE FORMALITY OF SUBMISSION OF CLUSTERS. (QUESTION: IS IT THE NORMAL PRACTICE THAT SUCH CASUAL BEHAVIOR OF THE UCPO WAS OBSERVED, AND HOW IS THE COMPILATION BEING SHARED WITH THE PEOS? SNAPSHOTS OF THE SUCH CLUSTERS ARE ATTACHED).
- * Three of the clusters taken by UCPO, were verified. THE SELECTION OF THE AREAS WAS FOUND TO BE JUSTIFIED IN ONLY 2 AREAS. All were taken within the 30 minutes of the geographical distance.
- * One of the clusters taken from Village Muhammad Ramzan Mashori by the UCPO had shown 1 REFUSAL FOR WHICH HE WAS FURTHER ENQUIRED. UPON FURTHER PROBING, THE STATEMENTS WHICH WERE PRESENTED BY THE UCPO DID NOT MATCH WITH THE TALLYSHEET DETAILS. This showed that UCPO either did not verify the child or had taken the cluster while the mobile team was vaccinating the same houses.
- * The UCPO had NO TEAMS MONITORING CHECKLIST WITH HIMSELF. UCPO HAD NO CHECKLISTS FOR THE TP AND FIXED SITE MONITORING TOO.
- * SMT SUPERVISOR MR. SYED ALI RAZA SHAH WAS ALSO MONITORED. MASHAALLAH,
 HE ALSO HAD NO CHECKLISTS AT ALL.

- * THE DEFINITIONS OF EVEN RCA AND MA WERE NOT CLEAR TO THE UCPO.
- * The UCPO was also non-familiar with the EI Categories.
- * Upon the field visit to the Village Suleman Kalhoro, T:03, Day 01,

Following children were found from the SMT Area which came within the category of Operational Failure.

- A) RABIA D/O MUNAWAR KALHORO 3 YEARS OLD.
- B) KHUDA BUX S/O MUNAWAR KALHORO 12 MONTHS OLD.

BOTH WENT TO KANDYARO ON SUNDAY AND RETURNED AFTER THE TEAM VISIT. BOTH WERE FOUND NOT RECORDED WITHIN THE TALLYSHEET.

C) MUHAMMAD HANIF S/O MUHAMMAD AMEEN 2 TO 3 YEARS OLD; WENT TO HINGORJA FOR THE MEDICAL TREATMENT BEFORE THE TEAM VISIT AND ARE NOW RESIDING AT SIDDIQUE KALHORO STILL).

ALL OF THESE ABOVE 3 CHILDREN WERE FOUND NOT WITHIN THE TALLYSHEETS.

Moreover, 2 Unrecorded Zero Dose Children were also found from the same village.

RECOMMENDATION: YOU ARE THEREFORE REQUESTED TO INITIATE ACCOUNTABILITY
OF THE UCPO AND MEANWHILE SUGGEST THE WAYS OF HOW TO BUILD THEIR
CAPACITY.
