With reference to the subject cited above, this is to highlight that the allegations against UCPO are of his involvement in dual job and misbehavior. Upon receiving complaint from CHW of UC Shahi Bagh against UCPO Mr. Ibrahim's unprofessional attitude and involvement in dual job, CTC team shared details with WHO PO on 29th Dec, 2020 and requested approval for joint inquiry into the matter by PTPP and CBV focal persons of CTC in presence of field supervisors (AC and PEO).

However, CTC team was not part of the inquiry and it was conducted independently by the field supervisors while as per policy, CTC team will conduct the investigations in such cases and upon arriving at findings shall share the report with concerned authorities. Moreover, statement recording of Subject UCPO was pending as he was on leaves when investigation was carried out. PTPP focal person of CTC was asked by field supervisors to accompany them only for recording the statement of the UCPO.

Your feedback in this particular case is requested as to whether CTC focal person should only accompany field supervisors in recording the statement of the alleged UCPO or should carry out independent joint investigation into the matter (including taking feedback from field supervisors).

#### Respected Madam,

Hope you will be fine with good health. I am writing to complaint about UCPO Ibrahim from UC Shahi Bagh. He shows misbehave and misuse of authority as a UC representative. He change his statement and telling lie, use harsh language with me in front of staff. He is not punctual in his duty and doing gold business during working hours. He took fake clusters and RCA's with the support of other staff members.

On 3rd December 2020, UCPO Ibrahim in front of UCO Benish, UPEC Shah Muhammad Sahib and TTM Ali, verbally harasst me. He shouted and telling lie that Area Supervisor Shama was absent and face domestic problem because of me, actually she was absent due to her domestic problem. Also blame and tell lie that on 2nd December, Area Supervisor Haseena and CHW Saima both were in support center at 12:00 o clock, although they both were in field at that time. He pressurized staff that they must be compile data till 1:30 and 2:00 o clock. He violate self respect and show

dictatorship among all staff. He did not allow me during Area Supervisors and CHW's training for fully participation. This is very difficult to work under a person who is not honest in his own duty and have not sense that how to talk and treat a female professionally. It is affecting the healthy atmosphere of the center. I hope that you understand my concern and take the required actions.
