Please find explanatory email shared by concerned TCSP on behalf of UCPO Muhammad Rashid. In readiness the issue was discussed and UCPO requested that the team will cover the area without security in low profile. Local teams do not prefer to take security because they are permanent residents of the area and are well known to locals. Due to sensitivity of the area, the local residents negatively perceive visit of LEAs to their door steps. Which may result in unwanted situation faced by our teams after campaign days when they are not escorted by security in their normal life activities.

In addition the area was planned on Day 3 but on the same day the issue was discussed at UC level meeting to cover the area soon after campaign. However the issue was not timely communicated to DEOC by concerned UC staff.
