The CTC will conduct the investigation independently without involvement of WHO, polio personnel or other counterpart in accordance with the laid down procedures. On the basis of the outcome of the investigation, the vendor focal person shall take either of the following actions:

b)	Moral harassment
•	In proven cases of extreme moral harassment, the offender will be given the opportunity to resign and may be provided an experience certificate.
•	In case of mild moral harassment, the offender may be transferred to avoid hierarchal and physical interaction with the victim and will be given a written warning.

A compliant of sexual harassment was lodged to DHO Mardan by LHV-Ms. Irum Begum and LHV-Ms. Asiya Jehan against UCPO-Mr. Tariq on 2nd December, 2020 (written complaint attached as annex A). As Government staff was involved, therefore, a committee consisting of EPI Coordinator, LHW Coordinator was formed in the evening meeting chaired by Additional Deputy Commissioner for carrying out preliminary investigation. Further it was recommended that UCPO-Mr. Tariq to be detached from campaign activities. The recommendations were finalized in the presence of WHO team members Area Coordinator Dr. Nazir and PEO- Dr. Fahad Asif and Mr. Haji Nazir, PCSO (Meeting minutes is attached Annexure-B). As per the recommendations of the district administration and keeping in view the SOPs, CTC issued suspension letter to the subject staff member on 4th December 2020.

A detailed inquiry into the matter was conducted by a committee comprising of DC LHW Program, District Coordinator EPI and ADC LHW Program (attached herewith as Annex-C) and report was submitted to DHO Mardan. The inquiry team hold UCPO guilty of misbehaving and maltreating female staff. The written statements of the staff members are also attached herewith as (Annex-D,E,F,G). Moreover, CTC team visited UC Khazana and had meetings with the concerned PEO and Area Coordinator. They also agreed to the conclusion of inquiry committee and had submitted their remarks about the scenario in written (attached herewith as Annex-J). Recommendations:

Keeping in view the findings of the inquiry committee and line supervisor's feedback, issuance of show cause followed by Contract Termination of UCPO Mr. Muhammad Tariq in case of unsatisfactory response is recommended.

In the evening meeting chaired by Additional Deputy Commissioner, Mr. Tariq was recommended to be detached from campaign activities in the presence of WHO team (Dr. Nazir, Area Coordinator Mardan, Dr. Fahad, PEO and Mr. Haji Nazir, PCSO).

CTC has recommended immediate suspension till the inquiry is completed. Your approval is required.
