He is working as Laboratory Attendant in Govt High School Pir Sahib since 2013, however he concealed the same from CTC.

The subject UCPO was issued show cause letter on 26th Jan, 2021 in order to record his stance and in response he denied his current regular job by stating that he had been appointed as IT Lab in-charge in 2013 but due to no position code in the same school, he was suspended/terminated. An investigation into the matter was carried out by CTC team and it came to open that the subject staff member is a regular employee in Education Department and is receiving monthly salaries on a regular basis (salary slips for the month of Dec 2020 and Jan 2021 are attached).

As per SOPs, concealment of dual job is a red line issue marked for zero tolerance, therefore his termination was endorsed by WHO PO (email appended). Moreover, as the staff member is withdrawing salary from another organization, so it is recommended that he shall not be paid salary for the month of Feb 2021.
