An explanation letter has been issued to Mr. Bahar Ali dated 1<sup>st</sup> Oct 2019 on account of unapproved absenteeism. As per his response, 23<sup>rd</sup> September was compensatory leave which was awarded by DPCR in lieu of working on Sunday 22<sup>nd</sup> September 2019. Due to an emergency he sent leave application to supervisor and did not wait for approval.

On 22<sup>nd</sup> September 2019, he forward 6 days (23<sup>rd</sup> to 28<sup>th</sup> September) leave request to PEO Dr. Samreen on account of some emergency. However, she did not endorse his leaves as in leave policy only 3 days leaves are allowed in case of emergency. On 24<sup>th</sup> September, CTC inform him regarding disapproval of his leaves and to resume his duty immediately.

During telephonic conversation with Bahar Ali, he old CTC team that he has come to Lahore to resolve his restaurant issue and will return to Peshawar on 25<sup>th</sup> September 2019.

His response is not satisfactory. He was absent without prior approval and the reason for taking leaves in emergency is also not justified. He is recommended for warning with salary cut.
