Greetings!

With reference to below email an explanation letter has been issued to UCPO Mr. Gohar Rehman dated 4<sup>th</sup> Oct 2019 on account of Poor Performance. His response summary is mentioned below.

- After receiving warning from supervisor in March 2019, I have performed my activities with full commitment.
- In pre campaign, Micro plan was updated and validated, provided support in team formation and training and provided support to UPEC Committee in social mobilization and CE activities.
- During Intra campaign phase, ICM cluster have been taken and are available for verification.
- Provided support to weak teams and monitor the teams, identified issues and shared with DPCR.
- During post campaign, tracking of missed children was done along with monitors.
- I have also provided support in Extensive outreach activity phase 6. During this activity I provided support in refusals coverage for essential immunization.
- I have fully supported the surveillance system in the district and reported an AFP missed by a faith healer and private practitioner from out of network system.

## **Key Findings:**

- He has been reported by external monitor for deficiencies in ICM clusters of CR August 2019.
- As per PEO feedback he has been reported consistently regarding his poor performance and negligence towards his assigned duties.
- He has already served with warning issued by PEO Dr. Ali Rehman in March 2019 on account of poor performance (*warning letter attached*).
- He was also notified through email in July 2019 with regards to improvement in performance as a result of performance appraisal.
- The NA children names are not mentioned in ICM cluster taken by him in August 2019, his signatures are missing and coverage details are also not mentioned in clusters (*ICM Cluster attached*).

## Conclusion/Recommendation:

Based on the previous performance record and evidences provided by his supervisor, it is concluded that he has lack of interest towards improvement in performance. He has given many opportunity to improve his performance but he has failed.

Therefore, he is recommended for final warning followed by termination of contract.
