Moreover he was supposed to visit the areas which are high risk or difficult to reach . He might have visited other areas but why he continuously neglected the hard to reach areas is the question of concern. Secondly being a tehsil level officer he was supposed to make and implement monitoring plan for each UC. Failure to do so warrants disciplinary action. Regarding his statement that his plan was changed by DPCR, it was for the last round not for the previous more than 7 rounds.
