I have read the email from your side. The Job you have mentioned ( Constable) I resigned in 2017 when it was known then Khassadar which was a kind of inheritance from forefathers. But when Mirwais told that if some have other activities let him be aware on time so I discussed my issue that My father was in Khasadar but due to some domestic issues he has transferred his Khasadari to my name at the age of 16 as I was the elder son of my father, after discussing with Sir Mirwais sb PEO of Khyber advised that submit a resign letter in the office. I had resigned on his advice and submit the documents to the office. The transfer was in process and due to my younger brother(Hijrat ullah) to whom the transfer procedure was doing had an age problem in CNIC so the transfer get complicated and the salary of the said Job withhold from 2017. Furthermore, as I haven't interested in the Khasadari Job and I haven't been in operation

for a single day during my entire service duration as i was dedicated for polio Eradication cause. Furthermore, I have again submitted request to withdraw my name as I'm no longer be the part of the said job. With the passage of in recent past in January 2021 I again submitted my resignation letter in the department and I have discussed the process with Kamran Kamal sb in front of Sir Ehtisham sb AC Khyber and he told me that bring the Documents( Resignation and NOC). so I can provide all recorded documents to your authority when needed, from the time when I have submitted resignation I haven't take the salary and I haven't been to the other office as i was and is committed to only the Job ( UCPO) I'm doing.
