The very next day UCOO Asma Malik called me to come into the room where supervisor Nazia, CHW Irum Kamran, and the communication team were present, As Nazia asked me to tell me where did I get this picture from? I denied revealing the source and told them my intention was to make her understand that she should not do this kind of things in the field rather AS Nazia and CHW Irum Kamran started shouting and all of a sudden Irum Kamran jump over me to snatch my cell phone I resisted and replied in anger do not force me to do something against you and do not engage physically otherwise I would not remain calm. My purpose is very clear I never wanted to make harm to anyone in any case.

2) Supervisor Misbah Kanwal asked me to drop her in her sister's home in Orangi, when we got off from the work, I sat on my bike in front of everyone and I dropped her in Orangi Town, to me it was not an issue to raise because few other supervisors and even UCMO took a ride when they need in the field and ask me to drop somewhere. I make it clear that I am not engaged with anyone emotionally or physically to anyone on my workplace.

3) I have also been accused of having an immoral discussion with Supervisor Nazia and Misbah Fahad, I replied on this accusation that it never happened and this accusation is based on falsehood and a set up to damage my credibility and reputation.

4) I have also been accused that because of my presence, the working environment is unbearable for women, to which I replied there is no such issue exist, you may have an open poll for that to see if this is true or not, and I also suggest that an unbiased inquiry should be conducted by interviewing everyone in the UC and I requested Dr. Umer to pay a visit for this purpose.

It is my assumption that the whole set up is prepared by the TDOSO Sir Tauheed Ali Kichi and AS Nazia and her Friend AS Misbah Fahad because 2 years back when Sir Tauheed was serving in Baldia Town as a DHCSO and he had an affair with AS Nazia, her Husband came to me and showed her conversation and voice notes and asked me to help him to get rid of DHCSO with her wife,
