

Qurban Ali Solangi Case (UCPO UC 7 - Dalmia, Gulshan Town):

1. Failed to comply with the task which is assigned to him regarding online update of ICM clusters timely NID Jan 21 (for which explanation was called on 22-01-21).
 2. When asked for Tally sheet analysis for NID Jan 21, he instead shared 2A form compilation. Although he is in the program since August 2020, he must be knowing how he is required to send the Tally Sheet analysis.
 3. Didn't attend UC level readiness meeting for NID March 21, which was held on 26-03-21, without any information.
 4. 2A link not updated timely on day 1 of NID March 21, Despite multiple calls & reminders. He didn't receive calls, nor called back. Also misbehaved when asked to update link timely. The deadline to update the link was 7 pm & Even around 9.27 PM; only District East was pending in data updating in whole Karachi just because of UC 7 for which DEOC received reminders from provincial EOC.
 5. Poor compliance to ICM submission caused delayed ERM at district level (NID March 21).
 6. Didn't share Tally sheet analysis for NID March 21 timely, for which email was raised to DEOC.
 7. Poor compliance to submission of tally sheet analysis resulted in delayed submission of reports, wrong format was used with copy paste of data
 8. Received complaints on email from UC 7 UCCO to DCO regarding behavior issues towards female staff working in UC 7; As per UCCO statement in his own words.
