Kindly review and approve the transfer of UCPOs.

**Summary:** 4 UCPOs in North Waziristan requested for a transfer (a reshuffling of duty stations) so that they would work in the UCs where they are actually from. There would be no change in numbers of UCPOs, only in location. CTC did the

physical verification of the UC, as per usual practice, to determine which UCPO is 'the most local'. Also they have taken the consent form from the UCPOs who are to be transferred.

The AC endorsed this move, and **Dr Gedi approved** the reshuffling of UCPOs in North Waziristan. Now CTC is requesting for clearance by federal office.
