Brief Details:

Mr. Tehsin Ullah was assigned the task of collecting the stool samples of notified AFP case PAK/KP/53/21/009 and submit to DEOC/DHO Office for further dispatchment to NIH Islamabad. Mr. Tehsin Ullah submitted the collected samples to the DEOC which were later dispatched to the NIH where it was notified to the district that one of the sample tubes was empty.

Upon enquiry from the UCPO Mr. Tehsin Ullah, he said that he had not checked the stool sample tubes when fetching from the patient guardian which is against the SOPs of stool sample collection process.
