Hope this email finds you well.

Let me share with you that I have traced a fake/ghost team in UC -3 Kharadar today on 10 June 2021. This was noticed when I visited to monitor and facilitate the Area Incharge Ms. Saima. I wanted to observe the performance of teams. When I inquire about the deployment of team # 4, Ms. Saima got perplexed. I insisted to see team # 4. She was muttering. It was enough to speculate the situation. I advised producing the means of verifications i.e., Micro Plan, Field validation, Desk Review, Summary Sheet, and the details of teams' deployment. At this point she confessed that:" There had been no team # 4 since last two campaigns.
