Dear sir, the said staff is apparently not interested in his job. He was supposed to submit his residence certificate on (date) but he never tried for his residency in Musakhail . I had communicated him several times and gave verbal intimidations and was trying to compensate on goodwill basis for over a month now. Please note that he was absent during entire period of pre campaign activities. Though he attended the campaign but on 4th day of campaign he immediately left the field without intimidating, did not attend the last 2 days ERMs. He was least responsive on my calls and text messages. Ultimately i had to inform CTC officially, upon which he was issued a show cause notice. In the reply of which he started making lame excuses and also blamed me about his absenteeism stating that i was the one who was supposed to arrange his residence (I had also agreed on goodwill basis~Despite this is not in my jurisdiction and domain) . But upon day of meeting with worthy Deputy Commissioner, he did not appear. Even during his show cause period he was not present in District. He is absent to date. Upon query on monday he bluntly told me he had left for Loralai and is now moving to Zhob as well. The reply of his showcase is humiliating towards me(Attached screenshot for official reference please).The matter is now subjugate to standard operating procedures of CTC, Provincial HR team and your kind self.
