Reference your email, i want to share that Mr. Tahir Hussain Jagirani UCPO Hazarwah had discussed this matter with IO Kambar and me. Keeping in view the genuine reasons behind his request, we had allowed him to proceed with formal request to CTC for transfer.

Furthermore, among the given options for filling this UCPO position from redundant UCPOs, I will recommend Mr. Israr Ahmed due to the reason that he is resident of Shahdadkot city and UC Hazarwah in fact starts from Shahdadkot city (two parts are bordering with Shahdadkot UCs). Distance from Shahdadkot to Last part will be hardly 20 KMs.

Mr. Agha Wajid Hussain is also good option, but he lives in village Aitbar and it is at distance of 5-7 KMs from two parts of UC Hazarwah near to city Shahdadkot, overall, it will take 25-30 KMs to reach at Last part of UC Hazarwah.

Both are good workers, further decision is at your end sir
