UCPO Mr. Saddam Hussain of district Dukki was issued show cause on account of 19 days persistent absenteeism. In his show cause reply, he admitted the allegation of absenteeism and stated that due to his uncle bad health condition, he remained absent.

IO Dr. Shahjahan shared his remarks in response to the show cause reply that he informed him, however, did not forward leave application as per agreed practice. He further communicated that it is his recurrent issue. Previously, he had also been remained absent without seeking prior approval. Moreover, he suggested to orient the staff pertaining to availing such leaves through proper channels before leaving the duty station.

Area Coordinator Dr. Zakia endorsed the IO's remarks.
