

I, Muhammad Tahir, do hereby denied allegation imposed upon me.

I have served in CBV Program from October, 2017 to 31st May 2020, and more than 80 workers and supervisor working under my command, no single allegation found upon me during this tenure, at that time staff few or most of them currently working in UC-01 Model Colony - that may be approached for further scrutiny of my activities and behaviour with them.

Indly I have been working as UCPO, UC-02 Saiduabad there to date and now 72 SMT workers and 9 Area Incharges and 4 Female UCNO are working with me. They may also be approached for further scrutiny.

I am not involved in any harassment, and the allegation mentioned in show-cause that I harass in favour of ginnis Job, it is clear that Union Council Medical officer is solely responsible for hiring and UCPo has no interaction in hiring and Smt worker are hired only for campaign duration so how can any give them permanent Job. These all are false allegation.

Another thing I would like to mention here that after that she (Tejseem) ~~and~~ asked me to start beauty parlour at Bhurani town, Bhotaspur for which she found the place and I gave her money for advance given to owner and then she went to Bolden Market with me to purchase cosmetics and dress beauty items for Beauty Parlour on the basis of Partnership -

- Which consist - upon
1. 25% Rent Expenses
 2. 25% Cosmetics and other necessary items
 3. 25% Tehseen share
 4. 25% Tariq Khan share

All the misdeed - in this I made in installment time to time as she demanded to buy furniture and other appliances, and this process start about 4 or 5 months ago but she didn't giving satisfied answers regarding business and every time made stories. When I asked her that you have no clear answer about Beauty Parlour Please sit to resolve this issue number of times after approaching she didn't reply me. one day we were in my session in TTD Tehseen and other lady kornal came to TTD office. Tehseen said Sir I have misplaced my car so Sir How can I collect my Payment from

Bank, I suggested her go to Police Station and launch NC for misplacement of your civic and contact - Ms. Shabana Rashid your UGMO for further assistance.

After few hours I received whatsapp calls & messages from unknown number that "sis I really wanted to meet you, I have seen you in media talk shows I am your fan". I asked her who are you she said I am Komal Same girl came with Tehseen at PHO office.

one day I received a call that I am Komal, sis me (Komal) and my mother nil of Karachi in our village due to my uncle death and I have no money to book tickets to return Karachi can you help me, I will

Return it as soon as possible, ^(S) then I sent her 3 or 4 thousand on her Civic via Jagash.

But immediately I shocked when I received text message from 3737 that amount you sent have been collected from GPO Karachi. I instantly called Komal that you were saying that you are at your village but money collected from Karachi. She said that she sent her cousin to collect money, I asked her that no one can collect money without Bio-metric How your cousin can collect money on your Civic.

She can't be satisfied by her answers and at that time I understood Tehseen and Komal are both cheating on Humanitarian ground as they were knowing my family is renowned to help the needy by Raskhans and clothes/medicines etc.

Another thing I would like to mention that before going village Kamal asked me that she need 3000 Thousand for medicine for her sister as doctors identified Stone in her kidney (Kamal little sister) for medicine I transferred her 2000.

another thing both Tehseen and Kamal was coming in contact - at some time which conf me very much and like same time, I asked Kamal that Tehseen is plotting some thing against me and you are the part of that - and the very next day this happened.
