Respected Sir

Response to explanation letter EL-KP-TD --066/December on account of Neglect of Duty.

During extended catch up activity 23 december when I return from the field to THQ for evening meeting the PTP supervisor Razi ullah vaccinated HRMP children in THQ mir ali. I along with AC, DHCSO went to the mountains to search and identify others children of HRMP. We search out but cannot found the HRMP in the mountain at last we meet with the local Herder in the mountain and give their exact location of HRMP. We all (AC, DHCSO, UCPO & PTP supervisor ) meet with HRMP families and vaccinate 30 children on the spot. On next day 24 December I along with TCSP and 2 unit supervisors went to verify their exact location. The HRMP families elders told us that we travel from Afghanistan via Wanna, Shakthoi of SWTD and enter into north Waziristan via Mir ali 5 Karkanwam to shogi and finally reach khushali mountain on dated 13-16 December. The HRMP families told us that total 40 day travel from Afghanistan to Khushali as we have a large no of Herd and travel very slowly. FYI as we have 33 members staff including 2 US , AS & CHWs excluding PEO & DHCSO before that no one were aware of such HRMP because they were not arrived before our NID December campaign and was not mentioned in Micro plan. Before that we have 10 HRMP which were also registered and were mentioned in Micro plan. On 23rd December i have registered all HRMP by names and vaccinated all the remaining children on the spot .

In my explanation letter This mentioned 40 days stayed in my UC, and this negligence is not based on facts. This mentioned negligence details are not based on facts. Actually these HRMP arrived on dated 15-16 December 19, and also eye witnessed both US and TCSP about their arrival date when we meet them i.e when we were confirming their exact location. That why these HRMP were not a part of our MP. The settlement of these HRMP is in security compromised area where no any one can go to these risky hilly areas. And no other population adjacent or near to these HRMP.
