Dear Shahid sb hope you will be fine. Dear sorry for inconvenience as busy schedule of campaign , PCM, EOR and mOPV 2 mission.

1. Dear the response of UCPO/TCSP not satisfactory as I already investigate and “detail discussion with PEO/DHCSO” the issue in the presence of UCPO , PTP supervisor, DHCSO concerned (block lead for same UC) that the settlement came 40 days before (one family came 11 days before and one family came 19 days) rest of 40 days.
2. If the nomadic settlement came on day 2nd of campaign then how can the children vaccinated at PTP THQ H Mir Ali on campaign day 1st (16 Dec 2019) of same family and 2nd time vaccinated on 23rd Dec 2019 ?
3. No information , No answer at that time with UCPO or others team till that time although we investigate in front of all team.
4. The children vaccinated by joint team (AC,DHCSO,UCPO,PTP Sup) and the statement given by elders in front of UCPO , why no objection at that time , even one family children vaccinated 19 days before at ex FR Bannu PTP team and UCPO again vaccinated the children after confirmation.

Visit of UC Mir Ali 4 and missed area of HRMP (Nomads/HRMP) Report

The NIDs Dec 2019 conducted in the North Waziristan tribal District from **16th-22nd December 2019 and one day extended catch up activities as per direction of DC/EOC Coordinator.**

During the extended catch up activity (23-12-2019) monday, one child covered from Nomadic Population (HRMP) at THQ H PTP and PTP Supervisor informed us that from same family he vaccinated two children before (two days later) during campaign days. Then I asked for investigation of father statement and addressed as concerned showed that how on extended catch up days they still unvaccinated. After discussion with father we became know that the settlement of Nomads established at Tarakai Mountainous area of Khushali, UC Mir Ali 4. We decided for visit of this area by myself for support the team in this high security compromised and hard to reach areas. Contact the concerned block lead DHCSO, UCPO and PTP supervisor Raziullah, take vaccine and went to the area for investigation of settlement and vaccination if found any missing. As during field search at least we found the settlement at area of Tarakai Mountainous zone, Border with Saintanga of ex FR Bannu, Kathira , Ali khel etc Mir Ali NW. The findings of the investigation as under:

- Total 10 houses (tent houses) from Nomads Afghanistan (Logar Province).
 - Total 30 Children vaccinated on the spot (3 children already vaccinated at THQ H Mir Ali by PTP Team & Supervisor).
 - Settlement Missed by UC Team (10 houses missed area/ “Tent houses”).
 - All UC team unaware from the nomadic population arrival/movement in the area. (Lake of interest /issue of field visit/Supervision & Monitoring/fear.
 - No HRMP record for the settlement in Micro Plan (The population since 40 Days in the location). .
 - Teams/AIC supervision by UC/Tehsil Team and identification of gaps (still challenge).
 - The issue of worst operational gaps of UC/Tehsil level observed.(already having one polio confirmed case in the area with same issue).

- Professional negligence and Poor knowledge of the operational area by Area/UC/Tehsil Team observed.

On job orientation done to the UC/Tehsil teams as well as refresher need to the UPECs and core team.

Overall, The DPCR need to be more **vigilant and professional** about **observation to avoid any unseen Movement/events.**

Recommendation:

- **Final Show Cause due to repeated poor performance** for all UCPO/US/TCSP concerned (UCPO Abidullah, TCSP Hayatullah, US Gul Daraz , US Quadratullah).
- **Show cayse for Concerned CHW/AS/AIC will do by DHCSO(Block lead).**
- **Refresher of Integrated Micro Plans** preparation with Desk/Field validation with strict supervision and monitoring of dist core staff.
- **Appreciation to PTP supervisor** of THQ H Mir Ali.
- **Capacity Building** of UCMO/DPMTs/TTMs/AICs.
- The **MOs** should be nominate as **UCMOs** and **involved with proper leadership.**
- Ensure the **accountability of poor performers** at all
- Ensure the EI/RI vaccination on priority basis.
