* Here I would like to mention that the whole reporting done by him is fake because he was not present in the field, when I visited the field (19 November 2021), he was not found in the field. He was called from Chaman to investigate the Viral Audio Call circulating in social media regarding fake data entry and Wastage of MR vaccine (AUDIO CLIP ATTACHED).

* During my visit, I observed that none of the campaign tally sheets starting from 15 till 18 Nov 2021 have his signature (PICTURES OF SOME RANDOM TALLY SHEETS ATTACHED FOR REFERENCE).

* The circulating fake Audio Clip, no signatures on all tally sheets, calling him from Chaman, arranging 01 team from Pishin for the campaign just to show us and misguiding us in the field for 3 hours, presence of single skill person in spite of 05 as mentioned in WhatsApp message from him dated 17 November 2021 (AS USED BY HIM IN HIS DEFENSE), No data validation by him.

* This issue was also discussed in ERM at RHC Maizai Adda and it was decided that organizational action be initiated and taken against all UC staff including him (COPY OF MINUTES OF MEETING ATTACHED).
