This is with reference to the complaint received against UCPO Ihsan Ullah UC Lahori Peshawar regarding his involvement in political activities (Attached as Annex-A). A show cause notice was issued to him dated 20th Dec 2021 to record his stance in writing, evidence received with a complaint is also attached as Annex-C.

As per the response of Mr. Ihsan Ullah (Annex-D), the allegations of participating in political activities, gathering, or running political campaigns are baseless and devoid of facts. His Uncle was contesting the election for a general seat and due to their joint family they were used to having a family gathering in Hujra but he never remains part of the political campaign. He admitted that he shared his Uncle's pictures on social media but his intention was not to convince anyone to vote for his uncle but it was shared due to the excitement of the election.

His response is considered satisfactory to the extent that he was not directly involved in his Uncle's political movements/campaigns and he was not asking for votes in the posts shared on social media, and his participation in gathering was due to cultural values to entertain their guest.

However, PTPP staff have been oriented and they have been instructed to avoid such gatherings and Post on social media. Therefore, a warning letter is recommended to refrain him from the repetition of such an act in future.
