On 24th December half of them were covered, however, due to public holidays and weekends, he could not collect the remaining data which he later collected on 27th and 28th December 2021 and shared with the supervisor on 29th December.

His daughter was severely sick and he admitted her to a hospital (hospital slip is attached as Annex-H) and he took leave dated 28th December from his supervisor.
5	Ateeq ur Rehman	UCPO	SMT	Deri Baghbanan	Failed to collect and submit Covid 19 Vaccination data within the deadline	As per the response of Ateeq Ur Rehman (attached as Annex-E), he was on leave till the 25th of December, and half of the staff were on compensatory leave due to which data could not be collected within the stipulated time.

6	Abdul Qadir khan	UCPO	Saddar	Badaber-Maryamzai	Failed to collect and submit Covid 19 Vaccination data within the deadline	As per the response of Abdul Qadir Khan (attached as Annex-F) to maintain the accuracy and authenticity of data and the high number of students in High schools, the principals requested to extend the time for collecting the desired data (Principal letter is attached as Annex-I) which was also discussed in meeting with UPEC and LHS. The authenticity of data was not certain which was collected by staff from other schools, so after verification, the data was shared with DSO on 29 December.
