# Based on the submitted response of Mr. Khalil Mahar, following are the feedback points from my side:

- He had himself admitted that the cluster was not filled by him but was filled from the Mobile Team members for which he was supposed to do monitoring. In half of his statement, that is also visible. Such kind of acts fall in the domain of Data Fudging when the monitor is claiming the performance of team under his account.
- 2. During the field visit, while doing NA validation and even visiting teams, he himself has also admitted that he has not visited those areas ever which are even on road side. Conducting UPEC does not justify his stance of non-familiarity with the villages.
- 3. One MP Copy is always placed at TSC by UCMO, so that defence is also not acceptable.
- 4. During his confession, he also informed that other UCPOs are also filling fake clusters (or from the teams) just like him. To verify his further statements, Dr. Suhail was appointed for this particular task. Following that claim, Dr. Suhail has also carried out accountability for another UCPO.

# His confession has also been recorded (Hidden) on the site, which may be provided if desired. <u>From our side, we cannot accept such level of data fudging acts and carelessness at this critical point in time</u> <u>for the Program.</u>
