Dear Mr. Naveed,

Thank you for the correspondence.

Kindly find the following notes attached:

1. Front of Tallysheet (AIC Kousar Parveen, Team #1): The UCPO has himself admitted earlier in the response that he was not provided the access inside the houses. How did the UCPO then gave the exact House Numbers in the cluster? Highlighted Houses are matching exactly with the Team's Tallysheet. This was also enquired personally from the UCPO to which he could not respond appropriately.
2. Back of Tallysheet (AIC Kousar Parveen, Team #1): The details of the children are mentioned in the highlighted areas. Since he could not collect the information personally therefore, he had just mentioned names by mixing gender (Razia with Razak). Age groups are also old. The sheet is also highlighting that the children were shown covered by Tick Mark in the back of Tallysheet (through the team). This was also confirmed by the UCPO personally later on that he has not vaccinated the children (Forging of data).
3. The first 3 children shown covered by Monitor in the cluster (Cluster form -Digital Data attached) are shown covered by the Team on the same day (28.02.22) as stated by 2A form (2A Form also attached).

Interviewer name: Dr Sundeep Area Coordinator  
Case against: Khalil Ahmed  
UC: Dhandhi

Three kids namely (Mahnoor, Munaiza, Saleha). Upon inquiring, Mr. Khalil who is Monitor for polio vaccination in UC Dhandhi, acknowledged that he did the vaccination of the mentioned 3 kids and in cluster he also put in his name. AC (interviewer) inquired to take him to kid's house where vaccination was done. AC inquired from Mr. Ijaz Ahmed who is father of the 3 kids whether Mr. Khalil did the vaccination of the kids or not. Mr. Ijaz confirmed that the vaccination was not done by Mr. Khalil but by one lady. After confirmation from Mr. Ijaz, Mr. Khalil accepted that he did not vaccinated the kids but the lady health worker did it. Mr. Khalil also confirmed, in past he did the similar practice by forging the cluster. Upon inquiring, Mr. Khalil also confirmed that he even has not visited 50% of the allocated UC. GD/GDA also has older posters with the name of dr. who is not working in this UC but the posters are still with his name.
