With reference to the below email, a show-cause notice was issued to UCPO Muhammad Tayyab UC Nahaqi – Peshawar on account of reporting fake deployment and late arrival.

As per the response of Mr. Muhammad Tayyab (*attached as Annex-A*), before the deployment of teams, they discuss the discrepancies in data that need to be corrected from fields. However, on 18<sup>th</sup> Feb 2022, he arrived late to the support center due to his daughter's health condition, so the teams were departed late. As far as concerned to the morning report, they share it before 9 AM and it is also updated from time to time. The report contains the information of those teams who will be departed to the field.
