Dear Naveed Sb,

Reference to the trailing emails regarding submission of fake tallysheet analysis and misleading the supervisors during the inquiry, the case is being forwarded to you for initiation of accountability measures laid out in the PTPP SOPs.

Following points are being submitted for your information.

INCIDENCE REPORT:

- 1. M.Maroof Hussain, deployed in UC 5 Bhawani Chali as UCPO submitted fake tallysheet analysis report without conducting this important post campaign activity.
- 2. The UCPO was asked by the TDOSO, his functional supervisors, to produce the hard copies of the analysis, to which the UCPO mentioned that he has done it in soft copy.
- 3. On further insistence by the TDOSO, the UCPO conceded that he has not done the analysis.
- 4. On 22<sup>nd</sup> March, the TDOSO raised the issue with the Area coordinator, who called both the UCPO and the TDOSO to the DEOC for inquiry.
- 5. During the inquiry the UCPO confessed of not conducting the analysis. He cited his wife's hospitalization as the reason of not conducting the analysis, stating that his wife is sick and in hospital for the last 3 days.
- 6. In response, the TDOSO raised that the analysis was due to be submitted before the days of the hospitalization, to which the UCPO failed to explain any further.
- 7. The UCPO was given an explanation (trailing emails) asking him to explain his position and also to furnish his wife's hospital documents.
- 8. In response the UCPO altered his statement, stating that his wife was hospitalized for the last 2 weeks and that he submitted the fake tallysheet analysis report due to the pressure from TDOSO.
- 9. The UCPO however failed to produce any medical documents in support of his claim.
- 10. The same evening the Immunization Officer Dr Haresh called the UCPO reminding him about the past deadline of submission of hospital documents. During this call the UCPO confessed that his wife is not sick, nor is she hospitalized and that he misreported the whole thing in order to defend/ cover up the fake submission.

#### **OBSERVATIONS BY THE AREA COORDINATOR:**

- 1. UCPO Maroof is a poor performing UCPO, which is reflective in his performance appraisals. The UCPO was also issued a warning letter in Oct 2021 on account of poor performance. (kindly refer to the previous evaluations and his administrative record)
- 2. The UCPO is found guilty of,
  - a. Gross misconduct on account of reporting fake/fraudulent data, in clear transgression of the disciplinary action framework policy, point 7.2; crossing the redline mentioned in the performance management and accountability framework-annexure 1 of the PTPP SOPs. The UCPO has confessed of fake submissions citing his wife's hospitalization as the reason.
  - b. Of making false/misleading statements about his wife's hospitalization in an attempt to mislead his supervisors.
- 3. The UCPO also confessed to the Immunization officer that his wife is not sick and he made up the story to cover up in misconduct.

#### RECOMMENDATIONS:

Based on the incidence report, the inquiry by the Area Coordinator, the confession of the UCPO regarding fake tallysheet analysis and false reporting of his wife's hospitalization to cover up the misconduct, the UCPO is found guilty of gross misconduct. In order to ensure transparency and setting the right precedence of accountability in matters of misconduct, it is recommended that M.Maroof Khan, UCPO UC 5 Bhawani Chali-SITE should be terminated from service with immediate effect.
