ENQUIRY FINDINGS

- Failed LQAS during NID-March-2022 (3 Children Missed by Team and 1 Refusal identified). UC is repeatedly failed due to operational issues
- 2. During NID-March-2022 Total of 4 Clusters were taken in the Area of CHW Salma where the monitors identified the missing of guest children as mentioned in the table below, but she was not supervised during NID May due to which she continued missing guests in 0/0.

- 3. Nothing was discussed in the Lesson learnt Cycle meeting and UPEC Meeting regarding operational failure
- 4. No data-based action plan is available at the UC level for improvement.
- 5. No plan for the capacity building of the Poor teams despite information shared by ERU.

- 6. The AS Rubina Ibrar failed the pre and post-test and was Not re-trained as a corrective measure. She was deployed without her capacity building and necessary coaching by UCPO.
- 7. On Catch up Day 1st, CHW Salma was not visiting the 0/0 Houses as per her statement as she perceived that 0/0 house is not required to be checked for any missed children. Which indicates poor quality of training. During inquiry, she failed to elaborate IPC questions despite working since 2019.
- 8. Sweep was Conducted by SALMA/CHW after detection by TPFM. Details are mentioned below.

 - Total #of Children found Unvaccinated: 16

Recommendations

- 1. It was proved that UCPO Ateeq did serious negligence as lead for the UC in areas of planning, supervision, data analysis, training, corrective measures and follow up of issues and is recommended for a warning and probation due to persistent poor performance.
- 2. AS Robina Ibrar failed to train her CHW properly and did not supervise her as she was one of her weakest team and is recommended for warning and counselling, followed by capacity building by the UC team.
- CHW Salma violated program SOPs despite instructions and is recommended for warning and counselling, followed by capacity building by the UC team.
