- 3. 1 seen refusal (Ayesha Zahoor)
- 4. 1 Other (1 Guest was not covered which came after chw Ayesha Zahoor visit)
- 5. Weak performance of AS Rubina Ibrar

1. On catchup day 1 during morning assembly clear instructions were given to all 17 chw's to visit half houses of 5 days and visit all missed children houses for maximum coverage 16 chw's followed instruction but some how Salma didn't follow although H/H fozia also instruct her to visit all houses but chw salma intentionally didn't visit after TVBMC found chw salma didn't have proper justification for this negligence.

On daily base analysis I checked that chw Salma recording high number of missed children on which instructions were given to UCDO Kiran for Na validation. After validation every Na was valid.

During NID March 2022 Special focus was on chw Salma due to High number Missed children, recording supervision plan is also attached with mail which clearly shows that 4 days continuously chw Salma was monitored and her missed children were validated and cluster also taken but no issues were found.
