It is responsibility of UCPO to ensure quality trainings in their UCs but due to casual attitude of Mr. Asif, the training lacked all the elements to make it fruitful one for the FLWs.

In this regard, it is requested to initiate accountability of the said staff by issuing him with Explanation and keeping record of his responses for future reference.

We have UCPO in this UC who was supposed to ensure all these but unfortunately his complacent attitude was very evident as he didn't try to take efforts to make things happen as per SOPs/guidelines. It is important

to mention here that on my intervention and interference, majority of the requirements were made available, and training started through stall methodology.

Please you are suggested to take necessary accountability actions against the concerned
