During the monitoring of Ghaghar part B missed areas including villages and hamlets had been identified by Mr. Zahid Jatoi TTSP of district Thatta near bordering area of Dhabeji. Many houses and hamlets were missed for more than two campaigns and according to some residents of hamlets more than 6 months no team visited this area.

On verification of identified villages by DEOC and PEOC team more areas were found with unvaccinated children . All children were vaccinated by monitors under their supervision

This serious issue raised questions on your supervision and monitoring and poor quality of microplan that was irrationalized regarding work distribution and hamlets were not included in Master list of hamlets You are directed to give a written explanation in this regard within 24 hours of receiving this email
