Thanks for the email.

For your kind information, District NWTD was assigned to Dr. Anwar (District Coordinator) and Dr. Rafeeq (IO, currently working as DSO Bannu since 1<sup>st</sup> July 2022) since January 2022.

I have gone through the show cause and explanation provided by UCPO Tanveer. As for as fake FM is concerned, none of UCPO or UCSPs have committed or being reported as doing FFM. The point of concern is if FFM is done on such a larger scale that we got Polio outbreak, why the UCPO was unable to dig it out. FFM has been reported multiple times by Tanveer. The UC Mirali 7, he is serving in is the largest and most populated UC having areas that are security compromised.

But the UCPO has been working since long, the issues leading to such a huge outbreak needed further follow-up and UC based data analysis which is missing. The same has been reported during field investigation of Polio cases and EPID studies done.

In this critical stage of the program, such kind of attitude is unbearable; therefore, strict disciplinary action may be initiated against the said UCPO.
