- UCPOs were assigned this task to submit UC level issues, resources needed and the way forward on prescribed format.
- They were given complete orientation on this task at DPCR Kambar.
- They were given initially 24 hours to submit this data, later on it was extended to 48 hours as few of the UCPOs were assigned one neighboring UC for the task in addition their own UC.
- Despite the fact that deadline was extended, majority of the UCPOs didn't submit the data even after 5 days of initial deadline.
- This is not the first time that UCPOs have failed meeting deadlines and/or showing compliance.
