Dear Sir,

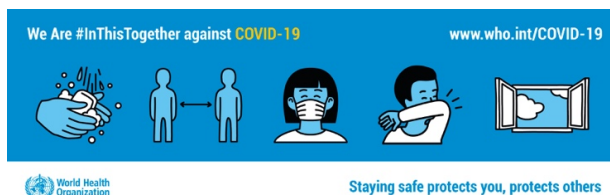
Forwarding you the email complaint received regarding UCPO Anila.

She has been victim of UCPO Aneela for more

than two months. ASPV Faiza Noor has been updating UC Level Staff Data for more than two months. Due to this workplace harassment, ASPV Faiza Noor is very depressed and overburdened. She has screenshots and all necessary evidence to prove this wrong use of authority and workplace harassment.

Respected Seniors,

It's very clear in WHO policy to respect co-workers and avoid harassment. And for that purpose, WHO introduces different online courses regarding harassment. But it seems that all those courses are in vain as UCPO Aneela's behavior towards ASPV is totally different.

Our respectable UCMO Dr Waqar Burdi has witnessed this harassment recently and has brought this issue into light. Therefore, upon request of UCMO Dr Waqar, I am sharing this email with higher ups. It is humbly requested to seniors to thoroughly investigate this issue and necessary action must be taken if found guilty. Also, application written by ASPV is attached below
