As I was coordinating hiring of DMs for TCV campaign, let me intervene and clarify that Extension of ONE MONTH was agreed till November 30, 2022 not till Dec 2022 in the last NPOs meeting during Sep 2022. We had P.O of 100 monitors and engaged 87 and from savings of 13 monitors we committed for only one month extension not two months.

Unfortunately, extension of these 87 DMs for 45 days (after campaign) couldn't result into a single financial closure with Financial team (which was sole purpose of extension of DMs). Provincial colleague, can better comment on the outcome of these DMs for extended month.

Dr. Ibrahim and team can guide and approve new P.O for hiring of these DMs if needed beyond Nov, 30, 2022. We need to initiate fresh P.O to serve the purpose.
