- Not a single AIC monitoring checklist uploaded in NEOC App by UCPO Qurat ul Ain since last three months
- No Team monitoring form has been submitted in NEOC App by UCPO in last campaign Investigation report and Desk validation report showing contrast is attached with email for reference
