It is to share with you regarding the incident on 12-1-23 UCPOs Musarat UC MITHI 3, Rahema UC BHUGRA MEMON, Peer Bux UC TARAI, Sachal UC GHARO, Yaqub UC AHMED RAJO, Shabir UC KADI KAZIA, Mukhtiar UC DUBI, Ifthar UC RAHUKI left OFFICIAL BADIN PEI WhatsApp group without any intimation to District officer/supervisor. Whole DEOC team and TFPs were surprised on this kind of attitude and un professional behavior from UCPOs on official group of WhatsApp.

On further enquiry, It is found that It is consequence of a clash between UCPO Musarat and NSTOP Dr. Karim Bux after which these UCPOs left group with some unwanted messages. Dr. Imtiaz (OIC in my absence) handled the situation and resolved.

On dated 18-1-23, UCPOs meeting was called for that matter and discussed the reason behind that incident. UCPOs replied that NSTOP misbehaved with our colleague, and no action was taken so we left group (written statements taken) and they wanted to make impression, they are united and no one can say anything to them. Immunization Officer and DSO explained to them that it is MISCODUCT OF WHO POLICY and such attitude towards work is unacceptable.

I recommend strong disciplinary action against all concerned. I hope you will give due consideration and take the necessary action for above matter.
