But its shows negligence in operational matter at your end as Jackets had been provided on 20 October at Baldia town (attached pic as reference) during training session and 2nd there were 4 untrained team members where being UC lead operation you should ensure to deploy trained teams so in this regards you should brief your position and reason for such negligence.
