As all of us are aware that Microplanning is the Prime responsibility/TOR of UCPO in his/her own UC during precampaign.

However, Mr. Alamzaib UCPO of High risk & drainage City UC-09 (working in program /UC for around 10 years) has failed to do so. UC-09 Microplan was desk and field validated on 7th March 2023 upon the directions of National-EOC. It secured 69% in Desk validation, 77 % in Field validation & 73.5% overall which is below the benchmark, leading to failure of MPQA for District Rawalpindi.
