It is for record and Information that preparation for upcoming NID is in full swing in khyber. Microplan preparation and its validation both desk and field wise is one of the most important activity.

During Feb 2020 pre campaign activities Mr Mirza Ali UCPO Ghundi B jamrud didn't validate his assigned area Microplan and submitted unvalidated Microplan to DPCR, which is very serious breach of code of conduct.
