Dear Naveed,

Please find below the serious observation regarding UCPO Sabiha that required an action.

- 1- Un pleasant act with influencer by UCPO in UPEC meeting.
- 2- Breach of policies to hire her sister as CHW.
- 3- Engaging in political activities in her assigned UC.
- 4- Disagreeable situation created by UCPO Sabiha at DEOC.
- 5- After working hours, she supposed to involved in extra activities.

The details of events are mentioned below for your more clarification.

1- An incidence took place during UPEC meeting when same influencer Mr. Qayoom Salarzai stood and started his speech. He said that the UC has grouping and influence decisions of the UC. He said that he wanted to refer one of the workers as supervisor, but the UC staff created hindrances, he named the UC staff. At this moment UCPO Sabiha and AIC Qurat ul Ain objected and retaliated to the accusation and became loud and harsh. Thus, situation became out of control and battlefield. Sabiha angrily threw the cups of tea Infront of all members and shouted. Her behavior towards the influencer at the recent

Union Council Polio eradication committee meeting (UPEC) was completely unacceptable. Her attitude and comments were inappropriate and not in line with the values and standards of **WHO**.

- 2- Furthermore, despite of clear instructions regarding hiring of workers that no blood relative will be hired under direct supervision. She did not follow instruction and violate the policies.
- 3- . **On 02-01-23** worthy Deputy commissioner South shared that an influencer Mr. Qayoom Salarzai complaint and it has come to his attention that UCPO may be engaging in political activities or favoring certain candidates without revealing their affiliations during the interview process. Based on favoritism/Nepotism highlighted by worthy Deputy commissioner South the said interviews for vacant position reconducted at DEOC on **06-01-23**.
- 4- Regarding the recent situation in which UCPO Sabiha, called for counseling at DEOC on 16-01-23 around 4.30pm. UCPO Sabiha refused to accept Unacceptable behavior towards an influencer at the UPEC meeting. Ms. Sabiha started yelling and shouting by saying that: 'I will look personally into matter and will do till last end'. In front of the other DEOC members, she was constantly yelling, and they watched the situation.
- 5- She went to one of CHWs house with AIC Quratulain and insist to hold the Holy book "QURAN MAJEED". regarding dispute that is about 2 Years Back old. Again, that is a behavior infraction.

This matter has discussed with DDPO and DC sahib, UCPO Sabiha has been mutually shuffled to Clifton -10 and UCPO Rashida to Civil lines-9 for temporary basis with immediate effect. After discussion with DDPO, kindly handle this issue as per HR policies.
