Apropos to your email concerning submission of explanation on my part regarding the mentioned task and my conduct at workplace, it is apprised that I had already updated the weekly zero-reports register along with requisite details as per your guidelines which you observed and were submitted to surveillance office Charsadda well in time. Meanwhile you inquired about the details of the reported AFP cases of the second last week which is humanly not possible to recall all the data, albeit all of the cases were timely and properly recorded in weekly zero-report register.*pic attached

Regarding the non-reporting of four Measles cases in zero-report register, it is clarified that these were not four cases as you didn't check the OPD register in detail. This was intimated to yourself three weeks ago but no heed was paid. Upon your inquiry about the non-reported measles cases during your last surveillance visit, the EPI technician assured you that no such cases have been referred by any doctor. The total cases reported up to January 14, 2023 were 21 only as per the OPD register record which was already signed by yourself as well.

Besides, my knowledge about the AFP cases in the tehsil assigned to me, it is added for your kind information that I had conducted in all UCs training sessions at BHU/RHC and THQ of all tehsil Shabqadar, met with HCPs and influencers and the attendance sheet is attached herewith for your reference. My performance could be assessed by comparing with other TPOs at referred cases, linkages and coordination in surveillance activities i.e. stool collection and submission within time. It is further added that most of the TTPs appointed for their respective areas don't perform all recommended members their duties properly which manifests poor management, lack of interest and ignorance of UCPOs / TPOs.

As per your accusation that my conduct is rude, it is clarified that you insulted me in front of permanent site staff of THQ Shabqadar and demonstrated unprofessional attitude which isn't expected in official environments. I was therefore compelled to report your misbehavior and unmannerly language to high ups of WHO for further investigation and I am positive that my request for a disciplinary inquiry would be considered. The explanation called by yourself is a preemptive attempt of safeguarding yourself and therefore I will request to higher authority to initiate an enquiry into all these allegations and establish facts in the best interest of establishing a professional work environment.
