Show-cause letter was issued to him on account of holding Data Fudging and in his response, he has denied the allegations leveled against him and His reply was termed as not satisfactory by supervisor .So the Supervisor decided to stick with the recommended decision, which came up in meeting of PEOC, his termination on immediate basis.

It is suggested that CTC management will issue him a Termination letter to acquire their stance and in case of an unsatisfactory response received, disciplinary action will be taken against him.

As for as my behavior is concern no doubt there might be some deficiencies in it which will be improved but I am very much surprised that my behavior was perfect around 7 years but unfortunately not satisfactory in 2022 and 2023, may be some times supervisors disagrees with my concern and I may be blamed as found misbehaved.

One another point was raised that I have been not visited my UC for a year, If I have not visited my UC than how come the progress of UC have been shown in the reports. At some point we are suffering from tribal enmities yes of course very minor area might be missed but data have been availed by the concern staff, If I have not performed well there might be deficiency in the supervision while taking and utilizing my performance up to the mark or as per organizational need and result orientated.

In the conclusion of my explanation I may say that Killa Abdullah/ Gulistan is very tough and hard area especially unacceptance of this program at the area with tribal norms and ethics which is the concept of the population in the area. Still with lots of challenges I have tried my level best to perform the duties with honesty and dedication.
