In continuation of the following email and area analysis. The CHW of the area reported for few fake NAs coverages in January 2023 campaign. The UC Officers were asked to have sweep her whole area and were asked to submit report of findings. The UCDO and UCPO did sweep through CHWs but with no major issues.

Now, in May campaign, I visited the area and came to know from the community that there was fake vaccination. Large number of still NAs and refusals recorded and convinced by the new shuffled CHW and communication team.

My concern is that why the UCDO and UCPO didnot shared this drastic change of the area when they are always asked to share issues and challenges of UC.

The officers need to be issued explanation and warnings so that they take reporting seriously next time.

Dear Sir,

As per your directions, analysis were done in one area of Tehkal Payan 1, where the CHW Nazish got terminated after January, 2023 campaign, due to few fake NA coverages.

As per the following analysis, in March campaign the recorded refusals graph increased from 6 to 60

And NA graph increased from 76 to 135.

Total still missed children (R/NA) in **January** were 4 while in **March** total missed were 32.

In the current May campaign (3 days) total still missed are 44

This shows that the ex CHW was doing around 60% fake coverages.

Today, I visited the area and verified around 25 HHs. Many found chronic refusals and many other were having reservations and covered easily. They showed their concern that the ex CHW was doing just finger marking and have vaccinated children for the first time.
